# USA PASSPORT APPLICATION PACK FOR APPLICANTS LIVING IN AUSTRALIA

This guide is intended for the following applicants of **ALL** ages (under16 or over 16 years of age):

- Applicants who are United States citizens by birth in the USA and who want to **renew** their US passport or **apply for their first** passport;
- Applicants who had their US passport lost or stolen;
- Applicants who hold a US passport and need to have their name or photograph changed
- First time applicant for a U.S. passport
- Renewing a U.S. passport (including old passports issued 15 years ago)
- Applying for the replacement of a lost, stolen or mutilated passport
- Renewing a U.S. passport which was issued while the applicant was considered a minor i.e. under the age of 16

In this information pack you will find everything you need to determine whether you qualify for a US passport along with the relevant application forms and notes on how to fill out the forms.

## **Qualifying for a US Passport**

To be eligible for a U.S. passport within Australia, applicants **must** meet one of the following conditions. He/she must either be a:

- United States citizen OR
- United States National.

To **qualify** as a U.S. citizen or National, the **applicant** must establish:

## **Proof of U.S Citizenship:**

If you were **born in** the United States, you must provide a:

Certified birth certificate (must have impressed seal of the state in which you were born OR

Previous U.S. passport (15 years and older)

If you were **born outside** of the United States, you must submit one of the following documents:

Previous U.S. passport (15 years and older)

Certificate of Naturalization (must include exact date and place of birth)

Certificate of Citizenship (must include exact date and place of birth)

If not shown, include a certified foreign birth certificate

OR evidence described below if you claim any of the following:

Citizenship through **Naturalization of Parents** submit the certificates(s) of:

Naturalization of my parents(s) and

Your birth certificate and

Proof of your admission to the U.S. for permanent residence

Citizenship through **Birth Abroad to one U.S. citizen.** Complete the following forms and submit:

## Citizenship through Birth Abroad to two U.S. citizens

Complete the following forms and submit:

Consular Report of Birth (Form FS-240)

## Certification of Birth (Form DS-1350 or FS-545) or your foreign birth certificate

Parent's marriage certificate

Proof of citizenship of your parents and

An affidavit showing all of your U.S citizen parents places and periods of residence in and out of the U.S before your birth

## Adoption by a U.S. citizen – Please submit the following documents:

- Permanent residence status
- Full and final adoption and
- Your U.S citizen parent(s) evidence of legal and physical custody (Note. Citizenship through this method is possible only if the applicant was born on or after **02/27/1983**)

Other information may be asked for proof of citizenship

## **Applying for a first time US Passport**

Every applicant except those with a passport renewal in the last 15 years should fill out **Form DS-11** enclosed in this information pack.

The following applicants should also apply using this application form:

- applicants who are renewing a U.S. passport issued over 15 years ago
- applicants who are applying for the replacement of a lost, stolen or mutilated passport
- applicants who are renewing a U.S. passport which was issued while you were under the age of 16

You must apply in person at your local US Consulate for this type of US passport

## **Applying for a US Passport Renewal**

If your passport is over 15 years old you must apply as a 'First Time Application' using **Form DS-11** and must be supported by full documentation (i.e. full birth certificate and marriage certificate) or registration documents if applicable.

Those adults over 16 years of age whose passport is under15 years old and who can submit that passport with their application should fill out **Form DS-82.** 

If your name has changed, you must submit original documentation to reflect a legal name change, such as a marriage certificate or a certificate of name change

You must be at least 16 years old when your last passport was issued, within the last 15 years.

You may mail in your application to the Consulate serving your area of residence. For more information see 'Submitting your Application.'

## **Applying for a Lost or Stolen Passport**

Adults aged over 16 years of age should fill out **Form DS-64** along with completed **Form DS-11** enclosed in this information pack. You must report the loss or theft to the US Consulate serving the area you live in and the local police who will give you a Police Incident/Report number.

You must apply in person at your local US Consulate for this type of US passport

## **Applying for an Emergency Passport**

If you are traveling within 15 working days, and you can provide proof of this travel in the form of a paid travel itinerary, you may apply for an emergency limited-validity passport, which cannot be extended. You must fill out all of the relevant forms included in this application pack Same-day issuance is available for applications that are complete and straightforward. In some cases, however, we may be required to refer to the Department of State; therefore, some cases may take longer. Emergency passport applications must be made in person by the applicant. The cost of an Emergency Passport is the same as a full passport and when your emergency travel has been completed, you must apply for a full US passport and pay the associated fees.

If you believe that you have a genuine emergency, and you require immediate assistance which cannot wait until the next working day, please call the U.S. Consulate's after-hours paging service at:

You must apply in person at your local US Consulate for this type of US passport

## **Applying for a Child Passport**

Child passports are for minors under 16 years of age, even though the application **Form DS-11** should be filled out for the child. Parents also need to fill out **Form DS-3053**, Statement of parental consent. This form must be completed in the **presence** of a Certified Notary Public. Applications for children's passports are given special attention in order to lessen the possibility that a U.S. passport might be used in the course of international parental child abduction; **the consent of both parents is required.** 

You must fill out the application on your child's behalf and they must attend in person with one or both parents or legal guardians.

Additional documentation is required for a child's application:

- Proof of child's parentage/legal guardianship
- Proof of parent(s) identity
- If only one parent is present, the applying parent should submit a notarized statement signed by the non-applying parent, consenting to the passport issuance to the minor and a photocopy of the non-applying parent's identity document

If both parents/legal guardians are present at the time of the passport application:

Both parents must sign the passport application and provide proof of parentage/legal guardianship and proof of identity. Evidence of parentage may consist of the child's birth certificate listing names of both parents, Consular Report of Birth Abroad or Certification of Report of Birth or adoption decree listing the names of the parents, etc.

## If one parent is present at the time of the passport application:

If only one parent is present, the applying parent/legal guardian should sign the application and present proof of parentage. The applying parent must also submit a notarized statement from the non-applying parent consenting to the passport issuance to the minor and a photocopy of the non-applying parent's identity document. The statement may be typed or handwritten.

If one parent has sole custody/guardianship of the minor the following evidence may be submitted:

- Birth certificate or Consular Report of Birth Abroad listing the applying parent, as the only parent.
- Adoption/guardianship decrees naming only the applying parent/guardian with no provision limiting the minor's travel.

- Court order granting sole custody to the applying parent/guardian with no provision limiting the minor's travel.
- A court order specifically authorizing passport issuance to the minor regardless of custody or travel to a place where a U.S. passport is required.
- Court order declaring the non-applying parent or guardian incompetent.
- Death certificate of a non-applying parent.

If no documentary evidence of custody/guardianship/court order etc. is available, other documentary evidence that supports the applying parent's claim of custody may be considered. If no other evidence is available, the applying parent may submit a written statement under penalty of perjury setting out the circumstances that prevent the submission of documentary evidence.

You must apply in person at your local US Consulate for this type of US passport

## **Changing the Name on Your Passport**

The name on your passport should always match your legal name and the name should match the name in which you booked your travel. So if your name changes - either by deed poll or through marriage or a civil partnership - you need to get your passport amended. You can also amend your passport in advance.

If you wish to amend your name within one year of your previous passport being issued, you may do so free of charge by completing **Form DS-5504.** If your US passport is more than a year old then you must use **Form DS-82** or **DS-11**, whichever applies to your situation. When you apply to change your name, your current passport will be cancelled and a new standard tenyear passport issued. Your passport will be credited with extra time (up to a maximum of nine months) to cover any time left on your old passport.

You must provide additional supplementary information proving your change of name. This can be in the form of a marriage or civil partnership certificate, a deed poll notification or if you have reverted back to your maiden name, a letter from you declaring this along with your divorce certificates or marriage certificate showing both your maiden name and married name.

## **Changing information in your passport**

If you are applying to change information in your passport, you should provide the relevant documents to support this, in addition you must also provide:

- your current passport or
- your old passport the passport that has expired.

## Changing name on marriage

If you have married and wish to change your last name or want your passport to have the observation 'the holder is also known as' you must provide:

- your original marriage certificate and
- your old passport
- in order to have an "also known as" observation in your passport you will have to provide a primary ID in the "also known as" name
- One form or photo ID e.g. copy of your driver's licence, PR card or student card
   OR

- Two forms of identity e.g. full birth certificate and your current passport or a letter of explanation if you do not have one.
- Two identical passport sized photos one photo should be countersigned two identical passport sized photos one photo should be countersigned.
- Expired passport for passport renewal applicants only
- Marriage certificate if your name is different to birth certificate or a name change certificate

## Changing back to your maiden name

If you are divorced and wish to change your last name back to you maiden name you must provide:

- your original birth certificate and
- your original divorce certificate.

## **Changing your name**

If you have changed your name through naturalisation, a court order or by Deed Poll you must provide:

- your original naturalisation certificate, court order or Deed Poll
- primary ID in your new name

## **Completing the Application Forms**

The forms you print must be **clear** and **sharp** and **written in black ink**. Forms that are blurred or illegible will **not** be accepted. Do not sign your passport application form – this should be done before a consular official:

## You should print the application forms from this pack on:

- **8 inch by 11 inch white paper** (with no holes or perforations, at least medium (20 lb.) weight)
- On one-sided, full pages
- On **matte surface** paper (avoid printing forms on thermal paper, dye-sublimation paper, special inkjet paper, and other shiny papers)

**NOTE:** Some printers will reduce the photograph area on the passport application to less than 2x2 inches. Please make sure that the photograph area on the printed application form is 2x2 inches to ensure that the photographs you submit (also 2x2 inches in size) can be correctly attached.

## **Supplementary Documents**

## Proof of U.S. Citizenship.

Examples of this type of document include the following:

- An original certified copy of your U.S. birth certificate issued with the impressed seal of the state in which you were born (Hospital birth certificates, Notifications of Birth Registration and copies of documents certified by notaries cannot be accepted.)
- A Certificate of Naturalization or Certificate of Citizenship: If the document does not show your exact date and place of birth, then also include a certified foreign birth certificate.
- Consular Report of Birth Abroad (FS-240 or FS-545):If you were born outside of the United States to a U.S. citizen parent or parents and were registered abroad as a U.S. citizen.
- If you have been previously included in another's U.S. passport: Please bring the passport together with a certified copy of your birth certificate to show your date and place of birth.
- A U.S. passport issued over fifteen years ago.

#### **Proof of Identity**

You must submit supporting documents that prove your identity to the extent deemed appropriate by the agent.

You may submit one or more of the following documents for proof of identity.

The document(s) must contain your signature *and* physical description or photo that is a good resemblance of you. These may include the following:

- A previous U.S. passport
- Certificate of Naturalization
- Certificate of Citizenship
- Driver's license (learner's permit and temporary license not permitted)
- Government employee identification card/pass (Federal, State, municipal)
- Other information may be asked for proof of identity

If you cannot provide proof of identity, you must appear with an **identifying witness** who is a U.S citizen, non U.S citizen national or permanent resident alien who has known you for at least

2 years. The identifying witness must sign an affidavit of identifying Witness (**Form DS-71**) and prove his/her identity.

## **Name Change document**

If you would like your U.S. passport printed with a different name from the one that appears on the document you present as proof of U.S. citizenship, you must present evidence to reflect a legal name change, such as your marriage certificate, certificate of name change, or adoption decree. If your name has changed more than once through marriage and your birth name does not appear on your current marriage certificate, you must also present evidence of the previous changes, such as the previous marriage certificate(s) and termination of the previous marriage(s).

**Two, 2 by 2 inches** passport photos (roughly 50 mm square) with the head centered in the frame. The photos must be taken y a professional photographer and not be from a home computer or vending machine. **NOTE:** US passport photos differ significantly from Australian passport photos

# Other Supporting Documents Appointment confirmation sheet

**Self-addressed Express Post Platinum or Registered Post envelope**, in which to have your documents returned to you once processing is completed.

You must make a copy of all supporting documents (not the application forms) to leave with the Consulate. If photocopies are not provided, you will need to pay \$1 USD for each photocopy (if you are also applying for a Social Security Number, please make two (2) copies of each supporting document);

## **Passport Interviews**

To combat passport fraud the US government has introduced compulsory passport Interviews. The purpose of the interview is to verify that an applicant really is who they say they are. Interviews are conducted at the US Embassy or one of its Consulates. Applicants must book their appointment online. ## Where to Submit your Application

If you are **applying for a US passport** or **changing the name on your passport** renewal you must submit your completed application form and supporting documents by mail to the US Consulate General closes to the area where you live.

Applicants for **lost and stolen US passports**, **child passports and first time passport** (including the renewal of a passport issued over 15 years ago) must be made in person at the nearest US Consulate. ## **Passport Fees**

The fees for US passports are as follows in US dollars. U.S. Embassies and Consulates accept the fee local foreign currency equivalent to the current dollar (\$) exchange rate.

Payment must be made at the time of interview using one of the following options:

**Cash** - either US dollars or Australian dollars; The Consulates General in Sydney and Melbourne accept U.S. currency in the exact amount and in notes only. Change is not available for U.S. currency. The Consulate General in Perth **does not** accept cash payment in U.S. currency.

**Postal Money Orders & Bank Checks -** Personal and Company checks are not accepted. Payments can be in either Australian or U.S. currency, and must be payable to the "U.S. Consulate General". Other payees will not be accepted.

The Financial Management Center has advised that it cannot accept U.S. dollar bank checks from the National Australian Bank (NAB) for all US passport applications submitted at the US Consulate General in Melbourne. We regret any inconvenience this may cause.

**Please note:** The U.S. Consulate General in Perth only accepts postal money orders in Australian dollars. No form of U.S. currency is accepted in Perth.

**Credit card** - Visa, MasterCard, American Express. Credit Card payments must be tendered in person. If you are eligible to mail in an application, send payment via Bank Check or Postal Money Order. Do not supply credit card details through the post.

All credit card transactions are processed in U.S. dollars. The actual amount charged to your credit card will reflect the bank's exchange rate and, possibly, a transaction fee.

## **Passport Processing Times**

An application for a full-validity (ten years for adults; five years for children under age 16) passport will be sent to the United States for printing with a secure, photo-digitized image of the bearer. You should allow 15 working days for your application to be processed.

If you are traveling within 15 working days and can provide evidence of this travel, you may be eligible for an emergency limited-validity passport.


#### **U.S. PASSPORT PHOTOGRAPHS**

U.S. passport photo requirements do differ from British and European photo requirements. Because of the way the photos are digitized, we are unable to accept any photos that do not meet these specifications.

Please furnish two photographs that are:

- All photographs must be 2" by 2" (two inches by two inches), excluding any borders
- Make sure the photo presents the full head from top of hair to bottom of chin; height of head should measure 1 inch to 1-3/8 inches (25mm to 35mm)
- Eye height must be between 1-1/8 inches to 1-3/8 inches (28mm to 35 mm) from the bottom of the photo
- Photograph background must be white or off-white
- Applicant image must be centered and facing forward
- Photographs must be taken in color (NOT black and white)
- Position subject and lighting so that there are no distracting shadows on the face or background
- Be taken in normal street attire, without a hat, head covering, or dark glasses unless
  a signed statement in submitted by the applicant verifying the item is worn daily for
  religious purposes or a signed doctor's statement is submitted verifying the item is
  used daily for medical purposes

Your photograph must match the dimensions of the below sample, which is the same as the dimensions on passport application forms DS-11, DS-82, and DS-5504 .



#### A Note About Digitized Photographs

If you choose to submit digitized photographs, they must meet the passport photograph requirements or they will be rejected. Some printers will produce an unacceptable photograph in which the dots are seen, or the image is grainy. Acceptable photographs are printed on high-quality photographic paper, have a continuous tone image that is very photo-like, and show the subject clearly in focus.

## **Passport Photographers**

Provided the photographs meet the specified requirements for American passports as listed above, any photographer may take them. The Embassy cannot recommend any specific photographer, or assume any responsibility for their efficiency, integrity, or reliability. Fees and the service provided are a matter solely between you and photographer selected.

LIKE THE TRADITIONAL PASSPORT BOOK, IT REFLECTS THE BEARER'S ORIGIN, IDENTITY, AND NATIONALITY AND IS SUBJECT TO EXISTING PASSPORT LAWS AND REGULATIONS. UNLIKE THE PASSPORT BOOK, THE PASSPORT CARD IS VALID ONLY FOR INTERNATIONAL TRAVEL BY LAND OR SEA BETWEEN THE UNITED STATES, CANADA, MEXICO, THE CARIBBEAN AND BERMUDA. IT IS NOT GLOBALLY INTEROPERABLE AND IS NOT VALID FOR TRAVEL BY AIR TO OR FROM ANY FOREIGN DESTINATION.

### APPLICANTS WHO HAVE HAD A PREVIOUS U.S. PASSPORT BOOK AND/OR U.S. PASSPORT CARD

If your most recent passport book and/or passport card was issued less than 15 years ago and you were over 16 years old at the time of issuance, you may be eliqible to use Form DS-82 (mail-in or electronic application). Please inquire about eliqibility when you apply, visit our website, or contact NPIC. Address any requests for the addition of visa pages to a Passport Agency or a U.S. consulate or embassy abroad. In advance of your departure, check for any visa requirements with consular officials of the countries you will be visiting.

#### SPECIAL REQUIREMENTS FOR CHILDREN

AS DIRECTED BY PUBLIC LAW 106-113 AND 22 CFR 51.28:

To submit an application for a child under age 16 both parents or the child's legal quardian(s) must appear and present the following:

- · Evidence of the child's U.S. citizenship,
- Evidence of the child's relationship to parents/guardian(s), AND
- Parental/guardian identification.

- Second parent's notarized written statement consenting to passport issuance for the child,
- Primary evidence of sole authority to apply, OR
- A written statement (made under penalty of perjury) explaining the second parent's unavailability.
- AS DIRECTED BY REGULATION 22 CFR 51.21 and 51.28:

Each minor child applying for a passport book and/or passport card must appear in person.

A birth certificate must include your full name, the full name of your parent(s), date and place of birth, sex, date the birth record was filed, and the seal or other certification of the official custodian of such records.
  - 1) If the birth certificate was filed more than 1 year after the birth: It must be supported by evidence described in the next paragraph.
  - 2) If no birth record exists: Submit a registrar's notice to that effect. Also submit a combination of the following: an early baptismal or circumcision certificate, hospital birth record, early census, school, or family Bible records, or newspapers or insurance files. Notarized affidavits of persons having knowledge of your birth may be submitted in addition to at least one record listed above. Evidence should include your given name and surname, date and place of birth, and the seal or other certification of the office (if customary) and the signature of the issuing official.   - 4) If You Claim Citizenship Through Adoption by a U.S. Citizen Parent(s): Submit evidence of your permanent residence status, full and final adoption, **and** your U.S. citizen parent(s) evidence of legal and physical custody. (Please note: Acquisition of U.S. citizenship for persons born abroad and adopted only applies if the applicant was born on or after 02/27/1983.)
- c. ADDITIONAL EVIDENCE: When necessary, we may ask you to provide additional evidence to establish your claim to U.S. citizenship.

#### 2. PROOF OF IDENTITY
